## **Review Previous Minutes**

# **COVID-19 Ways to Help our Community**

Justin led a discussion about ways we might assist our community during these times. This resulted in the following recommendations:

- 1. Hunger Offerings and Clergy Discretionary Fund at Saint Mark's, NW Harvest
- 2. Donations to UCEF Saint Mark's provides \$1,250 in funding from the Clergy Discretionary Fund. Money supports Seattle zip codes (not supported by UCEF) for rent and utilities to help residents stay in their homes.
- 3. Casa Latina provides job opportunities for domestic workers and day laborers, we support them.
- 4. Community Lunch preparing take out lunches now instead of serving hot meals. Fundraiser was cancelled and they need financial support.
- 5. Undocumented and DACA, check with Nancy for direction or we can support agencies who are serving them.

# JubileeUSA - COVID-19 Letter

Betsy received a letter from JubileeUSA requesting Saint Mark's sign onto a letter to the Managing Director of the International Monetary Fund, Kristalina Georgieva, asking for debt forgiveness for the next six months for the developing and developed countries. Good news shared that the IMF cancelled the debt on Monday, April 13, 2020.
