
What is Advocacy

- Organizing support for your cause
- Educating about an issue
- Developing positive, ongoing relationships
- Engaging on a long-term basis
- Advocacy is broader than lobbying
 - Advocacy is voicing support for an issue, policy or cause
 - Lobbying is a specific type of advocacy, focused on influencing legislation and elected officials




Why Advocate?

- Seek to change systems that degrade creation
- Become a catalyst for change
- Promote problem-solving
- Educate the community
- Create respect for a cause or policy



Why Advocate for Creation Care?

- To be caretakers of creation
- Use your time, talent and treasure for the good of God's creation and your community
- Support putting in place laws, regulations or policies with a focus on creation care
- Change peoples' behaviors so their values incorporate activities that help the environment




A Biblical Framework for Advocacy

- Proverbs 31: Speak up for those who cannot speak for themselves
- Isaiah 55: So shall my word be that goes out from my mouth; it shall not return to me empty, but it shall accomplish that which I purpose, and shall succeed in the thing for which I sent it.




Framework for Advocacy

- Start with the end in mind
 - Determine the goal
- Identify the target
 - Policymaker
 - Company
 - Community
- Positioning: Advocating on behalf of yourself or for an organization



How to Advocate Effectively

- Contact legislators & policymakers via
 - Meetings
 - Emails and letters
 - Phone calls
 - Invite officials to speak
 - Social media
- Partner with local organizations
- Alert individuals to legislation that protects creation
- Encourage engagement in civic activities and development of public policy



How to Advocate Effectively

- Build relationships before you ask for something
- Be respectful and professional
- Prepare a 60-second 'elevator pitch'
- Define who your idea will benefit, how much it will cost and how it will happen
- Do your homework and be prepared to address both sides of the issue
- Stay in touch to keep policymakers updated about progress and activities
- Always send a thank-you note



Tell a Story

- Stories put a face on an issue and resonate more than facts or figures
- A compelling story is better remembered by policymakers
- Use a story to explain who you are, what you do, where you live and your connection to the issue
- Share why the policy is important and how it affects you
- Create a memorable hook for them to remember you and your issue




Advocacy-Washington State

 - New/followup bills climate, toxics, habitat, growth, transportation
 - Budget for implementation
 - Comment via written and/or oral testimony, meet legislators
- Regulations, plans, reports
 - Department of Ecology toxics
 - Puget Sound Partnership



Advocacy - Federal

- Congress
 - Climate bills
 - Budget
 - Communicate with Representatives and Senators
- Key Agencies
 - EPA, NOAA, Transportation
 - Regulations, policies

Seattle environmental organizations

There are <u>378 environmental organizations</u> in the greater Seattle metro area, including the cities of Seattle, Auburn, Bellevue, Everett, Kent, Lakewood, Redmond, Renton, and Tacoma. Combined, these Seattle metro environmental organizations <u>employ 1,573 people</u>, earn more than <u>\$144 million in revenue</u> each year, and have <u>assets of \$205 million</u>.


