Public Policy affects Creation

- Laws can protect or exploit Creation, such as:
 - Environmental protection
 - Resource exploitation
- Election results affect Creation
 - 2024 is an important election year, locally and nationally
 - Elected leaders set policy
- Individuals can engage with public policy



Options for Policy Engagement

- Reflect, understand and heal through prayer and connection with the Earth
- Participate in movements for greater study, reflection and conversation across the Church
- Educate and encourage new actions and thought processes so that Creation Care becomes a way of life, embodying our Christian call to love God and neighbor
- Identify and address local, state and federal influence or advocacy opportunities
- Advocate for and support legislation and other public policies that directly address climate change's impacts



Examples from the Bible - Public Policy

- Proverbs 31: Speak up for those who cannot speak for themselves
- Daniel 4: Your Majesty, be pleased to accept my advice: Renounce your sins by doing what is right, and your wickedness by being kind to the oppressed.
- Esther 4, 7: I will go to the king, even though it is against the law. And if I perish, I perish... Queen Esther answered, "grant me my life—this is my petition. And spare my people—this is my request.
- Romans 13: Be subject to the governing authorities...
 The authorities that exist have been established by God.
- Matthew 21: Jesus went into the temple of God and drove out all those who bought and sold in the temple



Statement from the US Episcopal Church

 As we are called by God to care for creation, The Episcopal Church supports policies that protect the natural resources that sustain all life on Earth. The Church calls for policies that reduce greenhouse gas emissions, promote sustainable energy, encourage the safe and just use of natural resources, and support communities impacted by a lack of environmental stewardship and environmental racism.

 - Infrastructure Investment & Jobs Act




Policy in Washington State

2023 Washington State Policies Included...

- HB 1181: Changes to the <u>Growth Management</u> <u>Act</u> (GMA) to incorporate climate change into local government plans
- <u>SB 5452</u>: Transportation impact fee revenue spending on pedestrian and bicycle facilities, in addition to public streets and roads
- HB 1216: Permit process for clean energy projects that don't apply to the Washington State <u>Energy Facility Site Evaluation Council</u>
- SB 5412: Expands State Environmental Policy Act (SEPA) categorical exemption to include residential housing units, to facilitate more housing
- SB 5374: A city with a population under 25,000 may adopt the county's <u>critical areas</u> regulations to satisfy GMA critical areas requirements
- <u>HB 1544</u>: Expands the Shoreline Master Program review schedule to every 10 years



Governor Inslee's 2024 Priorities

- 3 policy proposals
 - Oil company accountability
 - Strengthen the state's cap-and-invest program to facilitate connecting it with others
 - Phase out methane gas
- Climate Commitment Act fund usage to include:
 - Convert diesel buses to electric and upgrade schools to improve air quality
 - Make sure affordable multifamily housing has clean and efficient energy
 - Install thousands of EV chargers
 - Partner with communities to design and develop sustainable neighborhoods
 - Enable Tribes to decarbonize
 - Assist Washingtonians with electricity bills

King County priorities

- King County says the Legislature can take 3 steps to mitigate and prepare for the climate crisis and address environmental decline:
 - Enact the WRAP Act, enhancing and growing product stewardship programs to make products safer
 - Increase Climate Commitment Act (CCA) appropriations to the Natural Climate Solutions Account, and provide CCA funding to local governments to reduce climate emissions, develop climate solutions and eliminate PFAS, 6PPD and other forever chemical pollution
 - Increase funding for the Trust Land Transfer program.



Protect Our Climate and Environment

Seattle Priorities

- Mayor Bruce Harrell
 - Building Emissions Performance Standards (BEPS)
 - One Seattle Climate Justice Agenda
 - Building an Equitable Clean Energy Economy
 - Ensuring a Just Transition Away from Fossil Fuels
 - Building Healthy, Climate Resilient Communities
- City Council
- Office of Sustainability & Environment



Citizens' Petitions

- <u>I-2117</u> to repeal the <u>Climate</u>
 <u>Commitment Act</u>
 - Let's Go Washington has turned in petition signatures for proposed initiatives to the Legislature.
 - If lawmakers don't take action in the current legislative session, initiatives automatically go to the ballot.



Impacts of Policy on Consumers

Impacts include:

- Cleaner air and water
- IRA incentives for EVs, solar power, heat pumps and more
- Tax exemption for solar in Washington
- CCA impact
 - Gas prices 5¢-50¢/gallon higher
 - Methane (natural) gas prices higher
- Convert diesel buses to electric
 - 10,000 school buses > \$2.35 billion

Earth Ministry Priorities

- Raise up a multifaith voice for environmental justice in the state legislature
- Cumulative Risk Burden (CURB) Pollution Act: Applies the HEAL Act to health-impacting pollutants in overburdened communities
- 100% Clean (Zero Emissions) School Buses HB 1368: (1) a switch (from diesel) to 100% clean, electric school buses, and (2) a funding source (CCA)
- The Washington Recycling & Packaging Act (WRAP): Curbside recycling for all WA residents, incentives for sustainable packaging
- Others
 - Holding Oil Companies Accountable
 - Community Solar
 - Navigator for Energy Cost Savings & Access



Statewide Coalition Priorities

- Environmental Priorities Coalition 27 statewide environmental organizations
 - WRAP Act: Combat plastics pollution and climate change
 - School districts to replace dieselpowered buses with electric ones
 - Oil firm transparency for gasoline and diesel prices
- Washington Association of Land Trusts
 - Community forest programs residents in managing logging near where they live
 - Salmon Recovery Funding Board and the Estuary & Salmon Restoration Program
 - Ensure Climate Commitment Act (CCA) Funds invest wisely in natural climate solutions























































Sierra Club – Washington State Priorities

- Defend the Climate Commitment Act
 - Defend the Climate Commitment Act from misinformation and powerful lobby efforts
- Expand Clean Energy
 - An equitable transition to 100% clean energy, incentives and regulations for more clean energy
- Clean Transportation for All
 - Convert Washington's school buses to zero emission vehicles
 - Encourage housing density around mass transit
- Protect Washington's legacy forests
 - A well-designed carbon credit program and funding to conserve more mature forests.



Suggestions for Priorities in Seattle

Commentary (December 2023)

- The Office of Sustainability & Environment says Seattle must reduce GHG emissions 50% by 2030 10%/year, 17 times our current rate
- For the mayor and the new city council:
 - Call on city departments for plans, schedules & budgets to cut transportation and building emissions 10% by 2024, 30% cut by 2026, and 50% by 2030 (transportation <u>causes</u> 61% of Seattle emissions, <u>buildings</u> 37%)
 - Pass an <u>update to the Comprehensive Plan</u> to address housing density & affordability
 - Call on stakeholders (business, labor, real estate, developers, education, healthcare, finance) to develop plans to cut emissions
